

RESPONSABILITY BIKE PARK LA MOLINA 2019

I, _____ declare that I understand that Downhill Mountain Bike is potentially dangerous and there are physical and material risks. I understand that while practicing Downhill Mountain Bike accidents can happen to others or me.

With that knowledge, I declare that I am fully capable of practicing Downhill Mountain Bike within the Bike Park of La Molina. I also declare that I am conscious of the kind of risks the use of those facilities could represent. For these reasons, I fully assume the responsibility of the possible casualties that could happen to others or me while using La Molina's Bike Park. Furthermore, I assume the responsibility of any damages to my equipment or the equipment of others within the Bike Park of La Molina.

Finally, I undertake a responsibility of proper use of the Bike Park facilities and I will respect the signals as well as the indications of the authorized staff, and therefore I will use appropriate material, which includes a helmet and protections to protect myself in case of possible injuries. And I assume that the non-compliance of the Bike Park's rules will result in the withdrawal of the access ticket pass. Such rules can be read at the headquarters and in the lower and upper cable stations, as well as all the La Molina Bikepark Trails Guide.

The ticket pass includes the obligatory insurance for mountain bike visitors and an insurance for personal accidents that covers the transfer and first aid in the closest hospitable center with a limit of accident coverage of 6000€, as in accordance with the Decree 56/2003 of physical sport activities in the environment.
